The Orangeburg Downtown Farmers' Market is primarily a farmer and grower market that also allows for local artisans, crafters and food vendors to participate in an effort to meet the needs of the community. The Farmers' Market operates under the direction of the Downtown Orangeburg Revitalization Association. DORA is the lead agency for the Farmers' Market and handles all operations of the Farmers' Market with support from project partners including the City of Orangeburg and others. Market rules and regulations have been established to provide regulations specific to the Market and are subject to change. The rules and regulations are mandatory for all Farmers, growers, crafters and vendors (herein called "Producer-vendors") and are part of the participation agreement. Participation in the Market can be revoked in accordance with the Program Rule Violations section. (Please read this summary carefully before signing the Participation Agreement.)
